

PNZ Member Insurance Survey

These Terms and Conditions govern the PNZ Member Insurance Survey Prize Draw (the "Prize Draw"). Your participation in the Prize Draw is conditional upon acceptance of these Terms and Conditions.

1. Promoter

The Promoter is BMS Risk Solutions (NZ) Limited (BMS), FSP 696531, NZBN 9429047279339, Level 4, 360 Little Collins Street, Melbourne VIC 3000.

BMS is the PNZ insurance partner.

2. Eligibility

- **Audience:** The Prize Draw is open to 2026 current PNZ members (insured and non-insured) who complete the PNZ Member Insurance Survey (the "Survey").
- **Exclusions:** Employees of PNZ and BMS, and their immediate family members, are ineligible to enter the Prize Draw.
- **Entry:** Only one entry per eligible PNZ member is permitted, however this does not preclude the entrant from winning multiple prizes. Entry is contingent on completing the Survey and providing the required contact details at the end of the Survey.

3. Entry Period

- **Start Date:** The Prize Draw commences on **Monday 9 February 2026** (the "Start Date").
- **End Date:** The Prize Draw closes at **5.00pm (NZDT) on Friday 27 February 2026** (the "Closing Date").
- Any entries received after the Closing Date will be void.

4. How to Enter

- Complete the Survey in full during the Entry Period.
- At the end of the Survey, provide your full name and email address.

Note: Participation in the Survey is voluntary. Providing contact details for the Prize Draw is separate from your survey responses and is required for entry.

5. The Prize

- **Prize:** There will be two (2) spot prize(s), each spot prize will be a \$100 NZD Prezy Virtual Card Visa (the "Spot Prize"). There will be one (1) overall prize at the conclusion of the entry period of \$500 NZD Prezy Virtual Card Visa (the "Grand Prize") (collectively referred to as the "Prizes").

- **Prize Value:** The total maximum value of the Prizes is \$700 NZD.
- The Prizes are non-transferable, non-exchangeable, and cannot be redeemed for cash or any other substitute. PNZ reserves the right to substitute the Prizes with one of equal or greater value if the advertised Prizes becomes unavailable.

6. Winner Selection (Game of Chance)

- **Method:** The winner(s) will be selected by random draw from all valid entries received by the Closing Date. This is a game of chance under New Zealand regulations governed by the New Zealand Gambling Act 2003.
- **Draw Date:** The Grand Prize draw will take place via an electronic selection on Tuesday 3 March 2026.
 - The Spot Prize draws will take place via an electronic selection on Thursday 12 February 2026 and Tuesday 17 February 2026.
- **Auditing:** The draw process will be witnessed by a non-participating PNZ staff to ensure fairness.

7. Winner Notification and Claim

- **Notification:** The winner(s) will be notified by PNZ via the email address provided by you at the end of the Survey, within 5 business days of the Spot Prize draw and/or the Grand Prize draw.
- **Claiming:** The winner must respond to the notification and claim the Prize within 10 business days.
- **Unclaimed Prize:** If the Prize is unclaimed after 14 days, or if the winner is deemed ineligible, BMS and PNZ reserves the right to conduct a redraw to select

- PNZ (and BMS) collect your personal information, including your name, email address and Survey responses, for the purpose of administering the Survey, conducting the Prize Draw, verifying eligibility, contacting winners, and analysing Survey responses to improve services.
